Dear Prospective Student,

Thank you for your interest in Alice Lloyd College. We are committed to seeing that international students have a quality educational experience.

Alice Lloyd College requires students to have a minimum 17 on the ACT or 1210 SAT score as well as a 2.25 core GPA from high school. International students must also submit their TOEFL score and a certificate of finance for evaluation by the Director of Admissions. The certificate of finance must also be supported by a bank statement. In order to participate in the work study program, all international students must have an F1 VISA and prior to enrollment must obtain a US issued Social Security Number. This can be researched at www.ssa.gov or it can be obtained at a local Social Security office upon arrival in the United States.

A limited number of international students are admitted to Alice Lloyd College; ALC is authorized under federal law to enroll non-immigrant, alien students. Students from other countries should submit this completed packet of information for evaluation by the Director of Admissions no later than June 1 for enrollment in the Fall semester and no later than November 1 for the Spring semester.

A \$3500.00 (US) deposit must be submitted prior to issuance of the SEVIS I-20 to assure the international student has access to money in case of emergency. This deposit, plus interest, is refunded to the student at the end of your college career-providing you do not owe the college. **International Students are not eligible for the ALC Scholarship-which is the tuition guarantee scholarship**. The only financial aid available to international students is the money earned from work study performed throughout the semester (160 hours per semester) (approximately \$1160.00) which is earned towards your tuition amount. Alice Lloyd College International Admissions Process

Applying for admission to Alice Lloyd College and securing your travel documents are two separate processes. One is determined by Alice Lloyd College and its admissions requirements for all students. The other is determined by the United States Federal Government and requires international students to submit certain documents used to determine their eligibility to legally enter the U.S. and study at a U.S. college or university. Due to the volume of information necessary to complete this process, we ask for your patience and understand that we are doing everything necessary to make this process easy for you. **Please be aware that none of the items necessary for admission are eligible to be waived.** Each process must be completed.

Everything you need for this admissions process is included in this packet. The application, certificate of finance, transfer clearance form-if transferring from another college in the US, your ACT or SAT scores and your official transcript from high school plus any college transcripts you may have must be submitted in this package for evaluation by the Director of Admissions.

If you are accepted to Alice Lloyd, you will receive another e-mail with your medical form and housing deposit form. These must be completed and returned to us with your VISA information necessary for your I-20 to be issued. It is also necessary to submit your \$3500.00 deposit at this time.

The total amount of yearly expenses must be supported on your certificate of finance; however, your bill is due at the beginning of each semester. Your personal expenses that you may incur are your responsibility. These would include such items as soap, shampoo, etc.
